Cases & Return to school	• Anyone with fever of 100.4 F. or above and/or one or more of the following symptoms: a new cough, new onset of shortness of breath or new loss of taste or smell should not return to school until 24 hours symptom free.			
Student/staff illness while at school	<ul> <li>Students who become ill should be masked (if not already) and separated in a space with minimal (preferably one) staff until parent or guardian can pick up the student. Staff attending to the student to follow infection control best practices for COVID-19. Clean/disinfect relevant areas.</li> <li>Students and staff immediately isolate in the designated area and sent home as soon as possible.</li> <li>Require the symptomatic person to wear a cloth or surgical mask while waiting, if tolerable.</li> </ul>
